

Hosted by the Asian Development Bank (ADB), this opening plenary sets the stage for the conference by moving the conversation beyond connectivity to focus on the quality and equity of economic participation in the digital age. The session will critically assess whether the new digital economy is fostering sustainable local entrepreneurship and decent work, or creating new forms of dependency, precarious labor, and market concentration, while also considering the ethical implications and dangers of data exploitation.

The GDAC Japanese Award for Outstanding Research on Development supports impactful research in low- and middle-income countries. Three finalists will pitch to a high-level jury for grants of US\$30,000, US\$20,000, and US\$10,000, along with mentorship from a leading academic.
